

West Side Coalition of Neighborhood Associations Report—May 6, 2009

The meeting was called to order by President Brett Lopez. Guests in attendance were State Representatives Bill O'Neil and Tom Anderson, PRC Representative Jason Marks, and Mayor Martin Chavez.

APD Captain Warfield reported that response times for priority one calls have significantly improved. The main reason for this improvement is the establishment of the new command center for Northwest Albuquerque.

Mayor Chavez spoke at length. He reported that because of the flat economy there is no budget growth this year. In prior years it has been based on three percent growth. Other cities are not doing as well, such as Tucson which decreased its budget by six percent. There are no city positions being filled except the critical ones such as 911 operators. Filling the director vacancy at our community center is not a priority.

He also said the city had acquired federal stimulus money to rebuild the I-40/Paseo del Vulcan interchange. This project will begin in a few months. Ladera and Pat Hurley Park landscaping projects are almost completed. Mayor Chavez also reported the Montano Bridge artwork has degraded over the years and the city is looking at real tile to redo it as opposed to paint.

Discussion occurred about the proposed new soccer field complex the mayor wants to build near I-40 and Paseo del Vulcan. APS is currently planning to build a sports complex near there, and Chavez believes it is productive to piggyback on the infrastructure APS builds.

State Rep Anderson reported that the gang recruiting bill died and the three-strikes sentencing bill failed. The failure of this legislature is disappointing because New

Mexico laws are not tough enough on gangs, and gangs from other states know it and are coming here.

City Councilor Ken Sanchez (Dist. 1) reported they are in discussions with the property owner and victim families to build a memorial park at the site where the bodies were found several months ago.

Councilor Michael Cadigan (Dist. 5) reports that he does not agree with the Mayor's proposal to build the soccer park near I-40 and Paseo del Vulcan. He believes that a much better location would be one near Ventana Ranch. He also addressed his disagreement with the mayor about the city budget, which may be going to court. He questions the need for \$60,000 for a hot air balloon, another \$60,000 for a billboard, and that a safe house for domestic violence victims is out of the budget.

Cadigan also expressed concern about the federal stimulus funds being used for the I-40/Paseo del Vulcan interchange (which he believes was pushed by developers), the I-40 exit for Route 66 Casino, and the I-25/Tramway intersection, when the Jefferson/Paseo del Norte/I-25 area is much more heavily used and in much more need of rehabilitation.

Jason Marks, PRC Representative, reported that a PNM rate increase is likely on July 1, 2009.

In new business, it was reported that the Coalition's website goes down on May 22 if it is not funded. Since a quorum was not present at this meeting, an online vote will take place. There were also concerns about the tiny little flag, to which we faithfully pledge our allegiance at each meeting. A larger more dignified flag will be donated.



Land Use Update

Waste Water Treatment and Reuse Facility/ Albuquerque Bernalillo County Water Utility Authority/ Sites Southwest: The Water Utility Authority held a facilitated meeting on May 7th at the Community Center to discuss their proposed zone change request to build a waste water treatment facility. They are seeking a replat and a zone change from SU-1 PRD to SU-1 for the public utility facility before they purchase 4.5 acres from Bosque School. The property is located between the School and the Open Space Parking lot.

The facility will be used to provide irrigation water for large turf areas such as Bosque School, Mariposa Park, and the Ladera Golf Course. They will tap an existing interceptor line that currently runs through the Bosque School property for a source of wastewater. Solid material in the wastewater will continue to travel on to the south side water reclamation plant for treatment. In the winter months, when irrigation demand is low, the reclaimed water from this facility will be discharged into the river. The facility includes an underground treatment area, with a permanent enclosed building above it, fitted with odor and noise control equipment.

There was good attendance at the meeting from the community. Residents questioned how large the facility would be and how would it look. They also questioned compliance with the Coors Corridor plan view regulations and the 100 ft. buffer as well as the odor and cleanliness of the discharge.

John Stomp from the Albuquerque Bernalillo County Water Utility Authority (ABCWUA) said there should be no odor. The facility would be similar to the Cabezon and Mariposa waste-water facilities in Rio Rancho, but bigger. There was no commitment on the size of the proposed building. John Stomp said the discharge would be clean enough to discharge into the river and parks but would not be used for drinking water.

The former owner of the property, Ray Graham, donated the property to the school for school uses. The school had talked of selling the property for town homes or offices. Now they are interested in the wastewater reuse facility, which they are planning to use for educational purposes for their students.

The La Luz representative expressed a concern on how the proposed facility will affect the neighborhoods in obtaining a high quality commercial development at the Daskalos property when it is eventually developed. La Luz has pushed for quality development on the Daskalos site

and has encouraged restaurants to be located closer to the Bosque instead of near Coors, in order to enjoy the natural setting.

John Stomp is scheduling a time for the neighborhoods to participate in a tour of the Rio Rancho Cabezon facility. He said that the proposed facility would take 10 to 20 years to complete. Sites Southwest is the consulting firm representing ABCWUA. So far the EPC hearing is scheduled for June 18th.

Coors Corridor Plan: On May 7th a group of west side neighborhood representatives met with city planners and members from the development community to go over the proposed Coors Corridor draft. The following questions came up:

- Should Coors Blvd. be eight lanes? The Coors plan will not be addressing how many lanes Coors should be, but this question comes up a lot. Many people from the Westside feel that eight lanes would be too much, and would make Coors even more difficult for pedestrians to cross. TRNA has taken a position to not support eight lanes for Coors Blvd. at this time.
- There were several questions concerning the view regulations. Should views be for people driving in the average size car or for people who ride higher in buses and SUVs or should views be for the residents already living along Coors? The Westside group pointed out that the current regulations are based on people driving the average size car not just buses, which mean everyone should be able to see the views along Coors when they drive or walk. The Westside group also favors residents living along Coors having views, but pointed out that recent development projects in the area are not designed to preserve views.
- The existing Coors Corridor plan (CCP) encourages contour grading and cluster developments like La Luz to preserve views. Current developments have been ignoring the CCP design recommendations. It was pointed out that the new proposed view regulations are weaker than the existing view regulations. The development community thinks the current regulations are too strict and would like to see the view regulations changed. The Westside group pointed out that the existing regulations have preserved views along Coors.
- We will be meeting with the City planners again on May 27th. The EPC is scheduled to look at this plan in July. If you are interested in the EPC hearing or any meeting on this subject, please let me know.

La Orilla/ Wal-Mart/ Appellant Issues: Councilor Cadigan completed his compilation of the appellant issues for the Taylor Ranch, Alban Hills, and Rio Oeste Neighborhoods. His report addresses all the issues that were brought up at the County hearings such as: traffic; the taking of Campbell's land; not following the current adopted Westside area plans; not following the conditions placed on the special use permit; and not following the County zoning code when the 1994 special use permit was approved. He will write up the Campbell's issues separately. The County now has to respond to our appeal and then the package will be presented to the Judge. We will set up a table at the TRNA flea market on the morning of June 27th, to collect money to help defray legal fees. Please give me a call if there are any items you would like to donate to this table to support our Appeal. Rio Oeste is also scheduling a neighborhood flea market for their homeowners association on Saturday morning June 20th. The money they collect will help defray the cost of their portion of the legal fees. Please feel free to attend both events to help support the appeal effort.

Dan Rich/ Storage Units/ Open House, May 8th: Dan Rich held a public open house to show off his attractive new storage facility. We wish him a lot of success.

City's Storm Water Quality Team/ Kathy Verhage: The City's Storm Water Quality team is offering to do a 15 to 20 minute presentation at Neighborhood Association general meetings, which make a request. They will explain the EPA's mandate for Cities to clean the discharge from storm drains before it enters our rivers. Unfortunately, they will point out that some citizen's believe that storm drains are convenient places to dump chemicals, yard wastes, paint and other harmful substances. To schedule a presentation at your Association meeting: please call Kathy Verhage at 768-3654. The Water Quality team is currently arranging a time to speak at the July Westside Coalition meeting.

City Open Space News: The City Open Space Department has bought the property at Coors Blvd and Bosque Meadows Road. This property known as Bosquecito was recently approved for a town home development by the EPC in January. It will now be an Open Space strip along Coors from Bosque Meadows Road to the Good Will Shopping Center, providing a nice buffer for the Open Space Visitor Center.
