

## President's Message

Ray Shortridge, President, TRNA

I am pleased to note two important positive developments in the land use area. First, the city council favorably acted on most of the points we raised in an appeal from the EPC and directed the EPC to schedule a hearing on the matter. Rene Horvath will cover this in greater detail in her article, but I urge you all to attend the EPC hearing Thursday, October 18 at 1PM.

Second, the developer applying for rezoning on the NW corner of Coors and St. Joseph, to accommodate a residential complex, has withdrawn the proposal from the EPC. Our position on the project that given the need for jobs on the West Side, it was inappropriate to rezone a property from commercial to residential.

The APD Northwest District Commander, Joe Christman, reports that the department has apprehended what it believes to be most of the gangs that were stealing wheels from pickup trucks and SUV's. However, Christman recommends keeping vehicles in the garage overnight – "find someplace else to store that few hundred dollars worth of stuff that fills up your garage in order to protect the tens of thousands of dollars you've invested in your vehicles."

### Correction to Sept. President's Report:

Regarding your vehicle registration, the original needs to be in the vehicle. Keep in a secure location. A copy may be kept in the glove box. The main point is not have any paperwork in your vehicle that has your social security number or date of birth.

### **THIS PROPOSED PROJECT WILL AFFECT THE BOSQUE!**

We need to promote a better use for this important land resource. Once a development is built, there will be no turning back. Fight for a true "village concept" development with a pedestrian-friendly design that doesn't harm the Bosque, Rio Grande, or existing nearby neighborhood shopping centers. A "Big Box" large retail facility will not meet the vision or goals that many of the neighbors and city residents are fighting for.

**The objective of the website is to educate you on the facts. Too often the people at WalMart tell elected officials and the public what "the opposition" is saying. You need to hear it from us directly. We are not against development and certainly not jobs.**

The site is already in the process of building an 8,000 sq.ft. Credit Union and 240 multi-family residences with garages. We are against building a Big Box on that site because of:

**Disregard of the city's approved Big Box Ordinances**

**Transgression of land use laws**

**Increased traffic at the city's 2nd busiest intersection and 4th most dangerous for wrecks**

**Proximity to a designated Bosque State Park (Wal-Mart back door just yards away)**

**Proximity to the Bosque School (adjacent to their property)**

**Crime rates for the two nearest Wal-Mart's — 1,127 serviced police calls in Y2011!**

**Harm to small retailers across the street**

**DONATE TODAY!!** The back of this Walmart will be adjacent (within 20 years) to the designated Bosque State Park entrance Featuring hand-carved tree statues honoring the firemen who fought the Bosque fire in 2004, and a Viet Nam memorial.

The site is on the edge of the Bosque, a riparian riverside forest, and abuts multiple state parks and open space which requires even greater adherence to the standards and regulations than offered. More than 122 vertebrate species have been identified. Any threat to the Bosque is a threat to the quality of life in ABQ. The Bosque is our Central Park.

TRNA represents the residents of Taylor Ranch to City, County, and State Governments, and the organization is recognized by the City of Albuquerque through the Neighborhood Recognition Ordinance, which allows the association to obtain notifications of impending issues that may affect the life of Taylor Ranch residents. ## Land Use Update

**1. Final hearing on the Declaratory Ruling appeal-September 5<sup>th</sup> City Council meeting:** As most of you know the City Council approved the findings for the Declaratory Ruling on September 5th. We could not move forward until this issue regarding the access requirements for a Big Box development was resolved. TRNA's attorney asked for a declaratory ruling last February to clear up the statement made by the ZEO at the January 19<sup>th</sup> EPC hearing. During the hearing, the ZEO told the EPC that the site had access for the proposed Big Box project. In response to our request for a declaratory ruling, the ZEO said the EPC will determine whether the proposal meets all the requirements in the LRF (Large Retail Facility) regulations, but even if the requirements are not met, the EPC had the authority to approve it. The City Council adopted a total of seventeen findings. Four of them addressed the ZEO's statements. A summary of the four findings follows:

**Finding #14:** The EPC case should proceed and the EPC should recognize that the ZEO has not made any statements, including her testimony at the January 19<sup>th</sup> hearing, that are binding on the EPC.

**Finding #15:** The Council finds that the ZEO erred in her declaratory ruling- to make an exception to the regulations of the LRF." The Planning Commission is charged with interpreting the Zoning Code in reaching its decisions. The language of the Zoning Code imposes mandatory requirements; the EPC may not waive such requirements.

**Finding #16:** The ZEO is not prohibited from issuing a declaratory ruling with respect to issues that are currently pending before a board or commission. The ZEO is not obligated to provide a declaratory ruling in such a case and should exercise discretion.

**Finding #17:** The City Council finds that the issue of site access will be an important issue if there is an appeal of the EPC case. The City Council requests, but does not order, that the EPC adopt findings that fully explain its determination of this issue.

**2. Walmart-EPC Hearing/October 18<sup>th</sup>/1:00pm/Convention Center -Ballroom A:** Its official, the EPC decided on a new date for the Walmart hearing. The EPC hearing is now scheduled for Thursday, October 18<sup>th</sup> at 1:00pm, in the Convention Center. The EPC hearing was originally set for September 25<sup>th</sup>, but was postponed after it was discovered that it fell on the Jewish holiday, Yom Kippur. Notices were sent out to notify the membership

about this change. This is the second EPC hearing for the Walmart project. The EPC Commission will decide whether to approve an amendment to allow a big box development at the Coors/ Montano site. This will be our final opportunity to make our case before the EPC. We are encouraging everyone to attend the **October 18<sup>th</sup> hearing.** Over 700 participants attended the last hearing in January. We need even more for this hearing. I know some of you work, so please plan to come after work or consider taking the afternoon off. This is a very important hearing and we need your support and participation. Any questions please give me a call.

**Funding Update:** All Library materials are funded through bonds: city, state and county. Materials includes books in both paper and all the various electronic formats, magazine subscriptions, all reference materials, audiobooks on CDs and in digital format, movies on DVDs, and database subscriptions.

On the ballot in November there will be two Library Bond questions, one from the State and one from the County.

**State G.O. Bond question B for Library materials** will propose \$9,830,000 to make capital expenditures for academic, public school, tribal and public libraries throughout the state. If this passes, ABC Libraries will receive approximately **\$872, 600.00** to purchase new materials over a two-year period. If the **County G.O. Bond Question #1 for Library Materials** also passes, then ABC Libraries will receive another **\$1.3 million** for purchasing new materials over two years, also.

ABC Libraries purchasing budget is much smaller per resident than any other comparable library system in our region. This is why our loan period for books is only 3 weeks, why we wait so long for popular items, and why we don't always find what we need in our Library. **Please make sure to vote "yes" on both library bonds this fall** and encourage your friends and relatives to do so also. This funding is desperately needed by ABC Libraries.

## Petroglyph National Monument Needs Helping Hands

Peter Piper might have picked a peck of pickled peppers. But for sure, people pecked a preponderance of Petroglyphs perched on what is now Taylor Ranch's western boundary. For hundreds of years people traveled to the volcanic escarpment to etch images into rock. Native people and then Spaniards hammered petroglyphs into barely yielding basalt. In time, as Albuquerque grew and west-side population increased the escarpment and its tens of thousands of petroglyphs and other archaeological features were recognized for their great cultural and historical significance. The ancient treasures and the open space surrounding them were set aside by the work of citizens and government leaders. Today, Petroglyph National Monument ([www.nps.gov/petr](http://www.nps.gov/petr)) is a central part of the identity and amenities of Taylor Ranch. However, there is concern about the management of Petroglyph National Monument that is attracting national attention.

The concerns have to do with the consequences of having multiple agencies, in this case the City of Albuquerque and the federal National Park Service, both having responsibility for care, protection, and management of the Monument. This is because about two thirds of the land of the Monument still belongs to the City and is jointly managed by the City's Open Space Division (<http://www.cabq.gov/parksandrecreation/open-space>) and the National Park Service. As with any relationship there are complications.

A national organization, Public Employees for Environmental Responsibility (PEER) ([www.peer.org](http://www.peer.org)), identified a lack of full authority for National Park staff to enforce protection regulations such as dumping of trash, off-road vehicle use, and vandalism within the City owned portions of the monument. PEER has started a petition and is urging the City of Albuquerque and Mayor Richard Berry to permit the Park Service staff to enforce all regulations across the entire monument. In its 6 June 2012 news release PEER stated:

*Under a five-year Cooperative Management Agreement, NPS and the City specify the delegation of their respective responsibilities for the monument. The City, however, refuses to allow NPS rangers to patrol or enforce Park Service rules on City lands, which constitute the bulk of the monument. Due to City service cutbacks, most of the Petroglyph is left unpatrolled. In a July 25, 2011 letter to PEER, NPS Intermountain Regional Director John Wessels stated –*

*“However, the NPS currently has no agreement with the City of Albuquerque that holistically authorizes NPS to enforce the entirety of 36 CFR Part 2 on lands owned by the city....We would welcome such an agreement and we have, in the past, proposed such an agreement with the City, but the City has not acceded to this proposal.”*

The process of creating Petroglyph took decades and involved neighborhood efforts, a Friends of the Albuquerque Petroglyphs citizen group, and the cooperation of both Federal and City of Albuquerque elected and appointed officials. Many partners invested considerable effort and public funds to create the Monument. It is important to many of us that officials continue to work together for the benefit of the community's investment, the Monument, and what is to many a sacred landscape.
